Memorandum of Understanding Between **Government College of Women, Sonipat** And Lex Foundation, Delhi

This Memorandum of Understanding is entered into on 26th April 2025 by and between Government College of Women, Sonipat, Affiliated to BPSMV Khanpur Kalan, Gohana (Sonipat) established in 2018, Haryana hereinafter referred to as 'the institute' and represented by its Principal, Dr. Naresh Kumar and Lex Foundation, a not for profit organization, established in year 2016 having its registered office at RZH 641, Street No 16, Raj Nagar Part II, Palam, New Delhi 110077, hereinafter referred to as 'the foundation, and represented by its President, Anish Singh.

Recitals:

- a. Government College of Women, Sonipat affiliated to BPSMV Khanpur Kalan, Gohana (Sonipat), the Institute involved in providing education in various streams like arts, commerce and Science having UG and PG courses.
- b. Lex Foundation, involved with their programs/initiative (Human Brotherhood, CarrerSpoc, Privilege Fellowship, Lex Olympiad) involved in contributing towards creating a peaceful and equal society by cultivating human potential though Advocacy & Awareness Campaigns, Career Support, Job Search, Livelihood and Employment Support and Career Oriented skilling to students and youths of India though collaboration with Schools, Colleges, Universities, NGOs, CBOs etc.
- c. The purpose of this M.O.U is to establish a collaborative partnership to work together for the mission of peace building, reduction of inequality, eradication of poverty, illiteracy though but not limited to the aforesaid programs. Objective of this collaboration include but not limited to:
- Providing accessible and professional counselling/mentoring services to the students of the College to support them with their Career and Education goals.
- · Fostering inter-cultural dialogue and understanding and providing opportunities through International Youth Conclaves to connect youths/students/professionals/industrialists from diverse background. with
- Enhancing the academic performance and overall success of the students
- Exploring more opportunity to address the social issues together for benefiting of the students of the Institute and society at the large to sustainable development goals.

Responsibilities:

The Institute:

- Contribute to the design and implementation of the program.
- Participate in joint planning and coordination efforts for the programs to be conducted jointly.
- Promote the objectives of this partnership within its network.
- Support, Coordinate and collaborate for programs of the Foundation.

The Foundation:

- Provide expertise, resources and technical support for implementation of the program.
- Facilitate networking and collaboration with relevant stakeholders.
- Mobilize volunteers and community engagement for the implementation of the programs.
- Support, Coordinate and Collaborate for projects The Institute.

Funding and Resources:

The Foundation shall arrange and secure the fund and resources required for implementation of the programs successfully.

For any program where both the parties agree in writing to work together to secure the funding and resources, the contribution and responsibilities of each party in this regard will be defined on a project by project basis.

Confidentiality:

Each party shall maintain complete confidentiality of any information of the other, disclosed during the term of this M.O.U. and adhere to ethical standards.

Monitoring and Evaluation: the partnership will establish a monitoring and evaluation framework to assess the progress and impact of the projects/programs. Regular Reporting and evaluation will be conducted to ensure accountability and transparency.

Terms and Conditions:

- Established/run/operated by and under Government College of Women, Sonipat, all Cells/Clubs/Faculty/Departments will be involved in above mentioned areas under academic collaboration.
- Established/run/operated by and under Lex Foundation, Delhi (Haryana) all active Initiatives/Program/Staff/Team/Volunteers will be involved in above mentioned areas under academic collaboration.
- In order to carry out the above activities, a detailed plan may be agreed upon for consultation between both parties (the institute and the foundation).

- It is implicit that every activity undertaken under this M.O.U. is approved by the appropriate officials of both parties (the institute and the foundation) and must fall within academic & fiscal constraint.
- In no event shall either party be liable for any indirect, incidental, special consequences other party in connection with, arising out of or under this M.O.U. save for any such loss suffered resulting from any wilful and grossly negligent act or omission of either of the parties.
- This M.O.U. represents a nonexclusive relationship between the parties and nothing contained herein shall preclude either party from participating/ Initiating similar relationship with third parties.
- This M.O.U. may not be amended without the prior written consent of both the parties.
- Both parties shall maintain confidentiality and protect the intellectual property rights of each other.
- This M.O.U. will be effective on and after the date of its signing by the authorized representatives of both party (the institute and the foundation) and shall remain in force until either party wishes to terminate.
- This MoU may be terminated by either party with a written notice of 30 days to the other party and termination shall not affect completion of ongoing projects unless otherwise agreed upon.
