## Memorandum of Understanding

The Memorandum Of understanding is entered on April 9, 2025 by and between **Government College of Women, Sonipat, Affiliated** to BPSMV Khanpur Kalan, Gohana (Sonipat), Haryana (established in 2018) , hereinafter referred to as 'the college' and represented by its **Principal, Dr. Naresh Kumar** and **Spread Smile Foundation Sonipat** (established in 2019) is an organisation for providing Education and Awareness to underprivileged children of society and performing other activities to save environment, having its office at Sonipat, Haryana hereinafter referred to as "the organisation" and represented by its Founder, Mr. Nitin Jain.

### Recitals:

- Spread Smile Foundation Sonipat** (established in 2019) is an organisation for providing health and Education facilities to weaker section of society and performing other social activities.
- Government College of Women, Sonipat affiliated to BPSMV Khanpur Kalan, Gohana (Sonipat) Institute involved in providing education in various streams like Arts, Commerce and Science having UG and PG courses.
- The purpose of this M.O.U is with reference to exploring the areas of cooperation, benefiting both the college and the organisation.

### Scope of Collaboration:

- The Organization and The Foundation agree to collaborate on organizing various educational events and awareness campaigns, workshops, guest lectures, and interactive sessions to educate students about skill-building and training sessions to create self-employment opportunities.
- The Organization and The Foundation will provide opportunities to connect the students with society by organising Health Check-up Camps, Blood Donation Camps and other social campaigns to eliminate some societal evils like smoking, drug addiction etc.
- The parties agree to share expertise, and knowledge to achieve the objectives of this MOU.

### **Responsibilities:**

#### **The College shall:**

- Promote awareness of motive behind this collaboration among students and encourage them to participate in the events.
- Provide administrative support for joint activities and ensure transparency.
- Coordinate with The Foundation to achieve the objectives of this MOU.

#### **The Foundation shall:**

1. Provide support to the organization for joint activities.
2. Ensure compliance with all applicable laws and regulations.
3. Monitor and evaluate the effectiveness of joint activities.

### **Confidentiality:**

Each party shall maintain complete confidentiality of any information of the other, disclosed during the term of this M.O.U.

### **Terms and Conditions:**

- Spread Smile Foundation Sonipat, (Haryana) will be involved in above mentioned areas under collaboration.
- Established/run/operate by and under Government College of Women, Sonipat, all cells/clubs/faculty/departments will be involved in above mentioned areas under collaboration.
- To carry out the above activities a detailed plan may be agreed upon for consultation between both of parties (the college and the organisation).
- It is implicit that every activity undertaken under this M.O.U. is approved by the appropriate officials of both parties (the college and the organisation) and must fall within academic & fiscal constraint.
- In no event shall either party be liable for any indirect, incidental; special consequences other party in connection with, arising out of or under this M.O.U. save for any such loss suffered resulting from any wilful and grossly negligent act or omission of either of the parties.
- This M.O.U. represents a nonexclusive relationship between the parties and nothing contained herein shall preclude either party from participating/ initiating similar relationship with third parties.
- This M.O.U. may not be amended without the prior written consent of both the parties.
- This M.O.U. will be effective on and after the date of its signing by the authorized representatives of both party (the college and the organisation) and shall remain in force until either party wishes to terminate.

- This MoU shall be valid for a period of three (3) years from the date of signing.

### Termination:

Either party can cancel or terminate this agreement unilaterally (and without reason), by giving an advance notice of one month to the other.
