

MEMORANDUM OF UNDERSTANDING (MOU)

This Agreement ("Agreement") was made on **1st July 2025**, by and between; **Government College for Women Sonipat (Autonomous)**, Sector-12, Sonipat-131001 (hereinafter referred to as "Stakeholder") of the First Part.

AND

Learning Links Foundation, a not for profit registered Trust having PAN number AAATL2587R and having its registered office at 1st Floor, Plot No. 2, Pocket C, Nelson Mandela Marg, Vasant Kunj, Delhi - 110070, India (hereinafter referred to as "Learning Links Foundation") of the Other Part.

1 Confidentiality

1.1 As used herein, Confidential Information ("CI") shall mean all information disclosed by one Party to the other pursuant to this Agreement which would reasonably be assumed to be confidential given the nature of the information and the circumstances of its disclosure, including information regarding the business, products, proposed projects, customers, clients and suppliers of a Party, and the existence, terms, and conditions of this Agreement.

1.2 Notwithstanding the foregoing, CI shall not include information that (i) is now in or hereafter enters the public domain (other than as a result of a breach of this Agreement by the other Party); (ii) is in a Party's possession prior to its receipt from the other Party; (iii) becomes known to a Party through a third party who has no duty of confidentiality to the other Party, (iv) is independently developed by a Party without reference to the other Party's information, or (v) is required to be disclosed by applicable law, government order, rule or regulation (in which case the Party required to disclose such information will notify the other Party prior to disclosure and reasonably cooperate with such Party in attempting to limit the disclosure to the extent permitted by law).

1.3 Each Party agrees to hold all CI of the other Party in strict confidence, not to disclose it to third parties or use it in any way, commercially or otherwise, except in connection with the performance of its obligations and the exercise of its rights pursuant to this Agreement. Each Party further agrees to take all action reasonably necessary to protect the confidentiality of the other Party's CI, and shall at least protect the other Party's CI in the same manner in which it protects its own CI of similar sensitivity.

1.4 Representations and Warranties

Each Party represents and warrants to the other that it has all rights and authority required to enter into this Agreement, and it has taken all requisite corporate and other actions to approve the execution, delivery, and performance of this Agreement.

All notices and other communications given or made pursuant to this Agreement shall be in writing and shall be deemed effectively given: (a) upon personal delivery to the Party to be notified, (b) when sent by confirmed electronic mail or facsimile if sent during normal business hours of the recipient, and if not so confirmed, then on the next business day, or (c) five (5) days after having been sent by registered or certified mail, return receipt requested, postage prepaid or by electronic mail (e-mail). 2. General

2.1 Parties have entered into this Agreement as independent entities and nothing contained in this Agreement is intended to create, nor shall it be construed to create any principal-agent relationship between the Parties. Neither party shall make any representations and shall not act or enter into any binding obligations, on behalf of the other Party.

2.2 This Agreement and Annexures contain the entire understanding of the Parties with respect to the Project and supersedes all previous communications, understandings, and agreements (whether oral or written), and cannot be amended or waived except by a writing signed by the Parties.

2.3 No failure or delay on the part of any Party in exercising any right or remedy shall operate as a waiver thereof; nor shall any single or partial exercise of or failure to exercise any such right or remedy preclude any other or further exercise thereof or the exercise of any other right or remedy under this Agreement.

2.4 This Agreement and all disputes relating to the scope, extent, interpretation, and meaning of this Agreement shall be governed by the laws of India. Courts at New Delhi shall have exclusive jurisdiction with respect to any dispute arising between the Parties in relation to this Agreement.

2.5 If any provision of this Agreement shall be held by a court of competent jurisdiction to be unenforceable, such provision shall be deemed to be deleted/omitted (to the extent reasonably possible) and the remaining provisions shall remain in full force and effect.


2.6 For purposes of this Agreement, (i) words (including capitalized terms defined herein) in the singular shall be held to include the plural and vice versa, (ii) except as expressly otherwise stated, the terms "hereof," "herewith" and "herein," and words of similar import shall be construed to refer to this Agreement as a whole (including all of the Annexures) and not to any particular provision of this Agreement, and (iii) the words "including" and "such as" and words of similar import when used in this Agreement shall mean "including, without limitation."

2.7 This Agreement may be executed by the Parties in counterparts, which may be delivered by facsimile transmission. Each counterpart when so executed and delivered shall be deemed an original, and all such counterparts together shall constitute the same instrument.

- Students will be able to get an opportunity to build their knowledge and skills in one of the most in-demand technology/STEM career paths of data analytics and AI.
- Students will be able to get an opportunity to the beneficiaries to hone their job readiness skills through focused skill-building workshops.

- Students will be equipped with the necessary skill sets to acquire self-reliance and productive participation in society.

- Placement and Internship opportunities will be provided by the Delivery Partner to the students of AMS Institute, who have enrolled in this program
- Conducting communication, skill-building, and job readiness workshops.
- Facilitating outreach through women's colleges/universities, standalone institutions, and colleges.
- The Program will be implemented free of cost and students will get certificates from sponsored courses, post the completion.
- Co-ordinate mentor sessions by Dell employees and take requisite permission for the same
- Collect and analyze relevant data or evidence (student data, Engagement Survey data, Educators survey data, qualitative data from student work, and other sources) to capture best practices.

2. Proposed duration of the Project: 01/07/2025 to 31/03/2026

3. Target Group: Women pursuing graduate studies from Government and Government-aided colleges across all boards (central and state) in Delhi NCR, Karnataka, Jharkhand, Haryana and Telangana

About the project

Women have been significantly underrepresented in Technology and STEM fields globally and within our country. According to a report by 451 Research, women constitute only 34% of the IT workforce in India, despite a 50:50 gender parity rate among STEM graduates. The World Bank reports that women make up less than a third of the world's workforce in technology-related fields. Low statistics persist: women hold merely 28% of jobs in computer and mathematical occupations and a mere 15.9% of jobs in engineering and architecture occupations. While there has been a gradual increase in women entering the technology workforce, a considerable gender gap remains, especially as women progress into higher positions.

This imbalance in critical sectors arises from various factors, including limited exposure and experience in STEM areas, inadequate pathways for career growth, and a lack of emphasis on employability skill development among women in these fields. The Women in Data program strategically confronts these challenges by inspiring and empowering women to pursue careers in high-demand STEM fields. It is designed to equip them with the requisite skills, knowledge, and growth opportunities, thereby enhancing their employability within the technology workforce.

- Offering beneficiaries, an opportunity to develop their knowledge and skills in the field of data and analytics.
- Providing structured guidance for participants to pursue and attain industry-recognized certifications, validating their competencies along a defined pathway.
